- **BY-LAWS** Chairperson Lipe, Kapraun, Brill Nothing to report.
- **HEALTH & SAFETY** Chairperson Hicks, Kapraun, Plumb, Tabit, Cole, J. Diekman, Herr The committee met and reviewed all the department SOG's. The recommended changes will be submitted for the May meeting and will be discussed at the June meeting.
- **PERSONNEL** Chairperson Gardner, Kapraun, Hicks With Chuck Lee's term being up as the Swing Board member, there is now a vacancy for the chair of the personnel committee. Rod Garnder accepted the position as the personnel committee chair.

OLD BUSINESS:

- **APPARATUS STATUS** Chief Plumb report expected delivery is the end of May and require time at the vender's shop to add the radio, computer and other services that were cheaper than using the manufacturer. Member Gardner inquired where the truck was purchased from. The vendor is R&R in Northville Michigan, the cab and chassis was built in Charlotte and final assembly in Bradnon South Dakota.
- MI-TREASURY GRANT AWARD Chief Plumb stated that the \$20,000 grant award was received and \$10,000 returned to each municipality.

NEW BUSINESS

• ACCOUNTANT POSITION – Chief Plumb reported that he has been taking care of the accountant responsibilities since May 6. This includes paying the bills, payroll, journal entries, taxes and reconciling the accounts. Chief Plumb felt that it would be difficult to find someone to train for the limited amount of time the job requires. Chief Plumb also stated that former Accountant Kim Borse was a tremendous help during the financial audit and assisted our staff at no cost to meet the audit requirements and requests and has offered to help when needed during this transition. Chief Plumb advised he did not make any former offers or discussion with Mrs. Borse but felt that due to her knowledge and expertise she should be compensated for her time. Chief Plumb stated he felt \$35.00 an hour was appropriate like the as needed wage provided to the Fire Truck Maintenance Supervisor.

Mr. Lipe asked if it was appropriate to pay her back pay for time, and Chief Plumb felt that was appropriate.
